Educational Experience

Each subspecialty has specific divisional conferences that fellows will attend throughout fellowship. These include but are not limited to journal clubs, research conferences and didactics that are subspecialty focused.

Improvement Academy

Problem-Solving for Fellows is a participative learning experience at Children's Mercy designed to allow participants to practice an A3 mindset

In addition to subspecialty-focused conferences, GME and Children's Mercy provide a full range of education courses and mentoring opportunities to guide fellows through each step of trainina. From orientation to preparing for faculty positions, our staff offers the knowledge and hands-on experience fellows need to achieve success in their clinical practice.

Common Curriculum

This monthly Core Curriculum Conference is required for first-year fellows and focuses on ACGME competencies related to leadership in professionalism, communication and systemsbased practice. Topics include:

Grant Writing Workshop

Fellows will complete a oneday grant writing workshop, along with a longitudinal curriculum to support them through writing a competitive grant application.

Fellows Orientation

GME provides a centralized twoday orientation to give fellows basic employee information and a brief Fellowship 101 course. Staff and faculty will provide knowledge and tips for how to thrive and gain the most out of the fellowship experience. Most importantly, orientation gives fellows an opportunity to create relationships with fellows throughout the institution.

Biostatistic Course

Fellows can take part in monthly biostatistics training with an introduction into various analysis techniques.

Scholarship Oversight Committee

The Scholarship Oversight Committee provides guidance and support for

trainees. The committee includes a minimum of three voting members. A chairperson is appointed or approved by the program director during the first six months of fellowship. The chairperson must be a faculty member of the fellow's subspecialty and be actively involved in teaching fellows.

Grand Rounds

Weekly conference with local and national speakers presenting pertinent pediatric topics.

Morbidity and Mortality Conference

Monthly conferences structured to define ways to improve quality of care through the analysis of recent cases.

Professor Rounds

Case-based presentations with an educational didactic component for hospital staff prepared and presented by a senior resident each week.

Additional Micro Sessions and Workshops

Fellows are invited to participate in any of the wide-ranging sessions offered by the Office of Faculty Development. These sessions are over the noon hour or on Friday afternoons and focus on topics of Pathways to Innovation.



Salaries and Benefits

The training programs at Children's Mercy provide a variety of perks, benefits and on-site services to help make the trainees' experiences positive and rewarding. All trainees receive benefits as prescribed in the Policies and Procedures governing Graduate Medical Education. Health and Dental Insurance

Trainees are eligible for group health and dental insurance for self and dependents, at the hospital's expense. Health and dental insurance coverage is fully explained in and governed by the health insurance plan and summary plan description.

Meal Stipend

Trainees will be provided meals through the hospital cafeteria at the hospital's expense when on-call at night.

Educational Stipend

Trainees are provided educational funds to use toward books and other educational materials.

Technology

Trainees receive a hospital-issued iPad or laptop.

Pagers

Pagers are provided at no cost to trainees by the hospital.

Parking

Trainees will be provided **free** parking at the hospital during the term of the appointment.

White Coats/Scrubs

Trainees receive a limited number of white coats/scrubs.

Moving Allowance

A moving allowance of \$500 is provided for any trainees moving from outside the metropolitan Kansas City area.

Long-term Disability Insurance

Trainees are eligible for a benefit equal to sixty per cent (60%) of their base salary if they are disabled for a period of at least ninety (90) days, in accordance with the terms of the life insurance policy.

Library

Trainees will be eligible to use all electronic library services and the on-site medical library located on the ground floor of the hospital during the term of the appointment; this library is available 24 hours, seven days a week. Trainees also have access to the library resources at the University of Missouri-Kansas City.

Vacation

Trainees are eligible for up to twenty (20) days of paid vacation annually.

Paid Sick Time Off (EIT)

Trainees will accrue one day (8 hours) of paid time off for illness after each full month of service.

Short-term Disability Insurance

Trainees are eligible for hospital-paid short-term disability.

Flexible Benefits Program

Tax savings are available through health care and dependent care spending accounts. In addition, you may pay your portion of premium cost for life, long-term disability, medical and dental coverage on a pre-tax basis.

Master's Degrees

UMKC Master of Health Professions Education

The Master of Health Professions Education (MHPE) provides an educational research foundation for teaching, assessment and leadership in health professions education. The MHPE curriculum is comprised of 12 courses which focus on the application of learning principles to educational practice. All courses emphasize an applied project based on students' professional experiences. UMKC Master of Science in Bioinformatics

The Master of Science in Bioinformatics supports the education of students interested in a career in bioinformatics or clinical research. Certificate Programs

UMKC Clinical Research

The Department of Biomedical and Health Informatics at the UMKC School of Medicine offers a Graduate Certificate Program in Clinical Research. The graduate certificate program is comprised of the core courses offered in the Master of Science in Bioinformatics Clinical Research Curriculum. It is a valuable credential for health care professionals (e.g., junior faculty, clinical fellows, physicians, nurses, pharmacists, dentists, clinical research coordinators) who want in-depth exposure to essential tools needed to advance their research career, but who are unable to devote the requisite time to a full master's degree program. UMKC Health Professions Curriculum and Evaluation

The Graduate Certificate in Health Professions Education provides an educational research foundation for teaching and assessment in health professions education. 11. Lenexa, Kan.


Lenexa is a Kansas suburb with great housing and school options.

Kansas City, Kan., is the area just north of KU Medical Center with good proximity to central Kansas City.


13. Overland Park, Kan.
